BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE PROCUREMENT OF MOTOR VEHICLE (B1)

Resolution No. 099-2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net,onMarch 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for Procurement of Motor Vehicle(B1)under General Services Section 2025 GAA with a total Approved Budget for the Contract (ABC) of Ten Million Eight Hundred Thousand Pesos (₱10,800,000.00);

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan Citywhich can be participated virtually through https://bit.ly/Prebid-CodeB-03172025;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only one (1) bidder purchased bid documents and successfully submitted bid, namely, Toyota Mabolo;

WHEREAS, upon opening of bid documents on March 31, 2025, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents. The bids were evaluated and rated as "PASSED":

WHEREAS, based on the preliminary deliberation, the bidder has been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 10, 2025 to determine the single calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the results of the detailed evaluation, Toyota Mabolo was identified as the sole and responsive bidder and was subsequently subjected to the Post-Qualification process to verify compliance with all eligibility, legal, technical, and financial requirements; however, it was particularly noted that the offered pick-up unit featured 265/65 R17 Alloy-GR Design as per brochure attached, which was initially marked as non-compliant with the specified Wheels:4-wheel alloy rims with at least R18 size requirement;

WHEREAS, upon completion of the Post-Qualification Evaluation, the BAC found that Toyota Mabolo complied with all the required legal, technical, and financial documents, and was therefore deemed the Single Calculated and Responsive Bidder. The end-user submitted and accepted a justification and certification stating that the manufacturer's standard R18 rim size offers advantages, particularly in terms of improved performance and durability for long-distance travel.

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, RESOLVES AS IT IS HEREBY RESOLVED, to recommend the award of the contract with a total amount of P10,076,000.00 to Toyota Mabolo;
