**BAC RESOLUTION ON THE RECOMMENDATION FOR THE AWARD OF
PROCUREMENT OF SOIL AMELIORANT (C17 – Lot 1)**

**Resolution No. 097-2025
Series of 2025**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on May 14, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement Of Soil Ameliorant (C17) under Rice Program** with a total Approved Budget for the Contract (ABC) of **Thirty Million Pesos (P30,000,000.00) with procurement by lot as follows:**

Lot 2 – 3,750 bottles soil ameliorants	P3,750,000.00
Lot 3 – 3,750 bottles soil ameliorants	P3,750,000.00
Lot 4 – 3,750 bottles soil ameliorants	P3,750,000.00
Lot 5 – 3,750 bottles soil ameliorants	P3,750,000.00
TOTAL	P30,000,000.00

WHEREAS, a pre-bid conference was conducted as scheduled on May 22, 2025 at the DA 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through bit.ly/Prebid-CodeC-05222025;

WHEREAS, the opening of bids was conducted as scheduled on June 3, 2025 at the DA 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through bit.ly/Opening-CodeC-06032025;

WHEREAS, six (6) bidders purchased bid documents and successfully submitted their bids. These were the **San Mateo Agri Trading, Aktiv Multi Trading Corporation Philippines, Inc., LDA Agri Marketing, Krempel Venture Inc., Agri-growth International Corporation, and Envireau Pacific Inc.**

WHEREAS, based on the preliminary deliberation, the two bidders have been found eligible and compliant with the requirements while three bidders have been declared as failed;

WHEREAS, upon opening of bid documents, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on June 10, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation:

- **Agri-growth International Corporation** is the lone bidder for Lot 1;
- **LDA Agri Marketing** is the lone bidder for Lots 2 & 4;
- **Envireau Pacific Inc. and Krempel Venture Inc.** submitted bid for Lot 3 with the same bid offer. However, **Krempel Venture Inc.** has no supporting documents for LCC, Other relevant docs no submission such as Latest tax certificate of stocks availability and other documents. No FPA product registration. Not compliant for the eligibility requirements;
- **Aktiv Multi Trading Corporation Philippines, Inc.** is the lone bidder for Lot 5. Their request for reconsideration was granted by the BAC specifying that the reflection of "comply" is true to all of the specifications reflected in the row;
- **San Mateo Agri Trading** was declared as failed;

WHEREAS, the BAC hereby resolves the following:

2. To declare **Agri-growth International Corporation, LDA Agri Marketing, Aktiv Multi Trading Corporation Philippines. Inc.** as lone bidders for Lots 1,2,4,5 and Envireau **Pacific Inc.** as the bidder with Lowest Calculated Bid for Lot 3, subject to post-qualification;

WHEREAS, to conduct post-qualification process to verify the eligibility, legal, technical, and financial requirements of the lone and lowest calculated bids;

WHEREAS, after conducting the Post-Qualification Evaluation on June 16-20, 2025, the BAC determined that the bidders met all legal, technical, and financial requirements and are deemed as the Lone, Lowest Calculated, and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, HEREBY RESOLVED, to recommend the award of the contracts to the following bidder:

NOW, THEREFORE, the BAC recommends the award of the contracts for the **Procurement Of Soil Ameliorant (C17 - Lot 1)** under **Rice Program** to the aforementioned bidder, subject to the approval of the Head of the Procuring Entity (HOPE);


