## BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE PROCUREMENT OF BIOFERTILIZER (C16 – Lot 6)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on May 14, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement Of Biofertilizer (C16)** under **Rice Program** with a total Approved Budget for the Contract (ABC) of **Thirty-Seven Million Five Hundred Thousand Pesos (₱37,500,000.00) with procurement by lot as follows:**

WHEREAS, a pre-bid conference was conducted as scheduled on May 22, 2025 at the DA 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through <u>bit.ly/Prebid-CodeC-05222025</u>;

WHEREAS, the opening of bids was conducted as scheduled on June 3, 2025 at the Da 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through <u>bit.ly/Opening-CodeC-06032025</u>;

WHEREAS, seven (7) bidders purchased bid documents and successfully submitted their bids. These were the **Global Green Organic Fertilizer**, Inc., Ahcil Laboratories, Inc., Two A & K Agricultural Nursery, ThaiPhil Advance Agritech Corporation, Classique Herbs Corporation, ADA Manufacturing Corporation, and Inavet Nutrition Technologies, Inc.

WHEREAS, based on the preliminary deliberation, the four bidders have been found eligible and compliant with the requirements while the three bidders have been declared as failed due to non-compliant;

WHEREAS, upon opening of bid documents, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on June 10, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation:

• Global Green Organic Fertilizer, Inc., ThaiPhil Advance Agritech Corporation, Classique Herbs Corporation, ADA Manufacturing Corporation, and Inavet Nutrition Technologies, Inc. were lone bidders and subjected to post-qualification;

WHEREAS, after conducting the Post-Qualification Evaluation on June 16-20, 2025, the BAC determined that the bidders met all legal, technical, and financial requirements and are deemed as the Lone and Responsive Bidder:
