

**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD OF  
PROCUREMENT OF HYBRID RICE SEEDS (C15 – Lot 3 and 4)**

**Resolution No. 167-2025  
Series of 2025**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on May 14, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement Of Hybrid Rice Seeds (C15)** under **Rice Program** with a total Approved Budget for the Contract (ABC) of **One Hundred Twenty-Three Million Eight Hundred Sixteen Thousand Pesos (P123,816,000.00)** with procurement by lot as follows:

WHEREAS, a pre-bid conference was conducted as scheduled on May 22, 2025 at the DA 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through [bit.ly/Prebid-CodeC-05222025](https://bit.ly/Prebid-CodeC-05222025);

WHEREAS, the opening of bids was conducted as scheduled on June 3, 2025 at the DA 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through [bit.ly/Opening-CodeC-06032025](https://bit.ly/Opening-CodeC-06032025);

WHEREAS, seven (7) bidders purchased bid documents and successfully submitted their bids. These were the **Rango International Corporation, Leads Agricultural Products Corporation, Acacia Agri-ventures and Trading Corporation, Aktiv Multi Trading Corporation Philippines, Inc., Seed to Rice Producer Cooperative, Greentech Agri-Grow Phils, Inc., and SL Agritech Corporation;**

WHEREAS, based on the preliminary deliberation, the seven bidders have been found eligible and compliant with the requirements;

WHEREAS, upon opening of bid documents, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on June 10, 2025 to determine the bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;



WHEREAS, the results of the detailed bid evaluation are as follows:

WHEREAS, based on the detailed evaluation:

- **Greentech Agri-Grow Phils, Inc.** is the lone bidder for Lots 1 & 2;
- **SL Agritech Corporation** is the lone bidder for Lots 3 & 4;
- **Leads Agricultural Products Corporation** is the lone bidder for Lots 5 & 6;
- **Acacia Agri-ventures and Trading Corporation** is the lone bidder for Lot 7;
- **Seed to Rice Producer Cooperative** is the lone bidder for Lot 9;
- **Ramgo International Corporation** is the lone bidder for Lot 10;
- **Aktiv Multi Trading Corporation Philippines. Inc.** is the lone bidder for Lot 11.
- There were no bidders for Lot 8 and 12;

WHEREAS, the BAC hereby resolves the following:

3. To declare **Greentech Agri-Grow Phils, Inc., SL Agritech Corporation, Leads Agricultural Products Corporation, Acacia Agri-ventures and Trading Corporation, Seed to Rice Producer Cooperative, Ramgo International Corporation, and Aktiv Multi Trading Corporation Philippines. Inc.**, subject to post-qualification;

WHEREAS, after conducting the Post-Qualification Evaluation on June 16-19 2025, the BAC determined that **Greentech Agri-Grow Phils, Inc., SL Agritech Corporation, Leads Agricultural Products Corporation, Acacia Agri-ventures and Trading Corporation, Seed to Rice Producer Cooperative, Ramgo International Corporation, and Aktiv Multi Trading Corporation Philippines. Inc.** met all legal, technical, and financial requirements and are the Lone and Responsive Bidders;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVED**, to recommend the award of the contract to the following bidder with the respective amounts as follows:
