

**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE  
PROCUREMENT OF INORGANIC FERTILIZERS (C24 – Lot 1 and 4)**

**Resolution No. 112-2025  
Series of 2025**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on May 14, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement Of Inorganic Fertilizers (C24)** under **Rice Program** with a total Approved Budget for the Contract (ABC) of **Three Hundred Fifty-One Million Nine Hundred Seventy-Nine Thousand Eight Hundred Pesos (P351,979,800.00)** with procurement by lot as follows:

WHEREAS, a pre-bid conference was conducted as scheduled on May 22, 2025 at the DA 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through [bit.ly/Prebid-CodeC-05222025](https://bit.ly/Prebid-CodeC-05222025);

WHEREAS, the opening of bids was conducted as scheduled on June 3, 2025 at the DA 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through [bit.ly/Opening-CodeC-06032025](https://bit.ly/Opening-CodeC-06032025);

WHEREAS, three (3) bidders purchased bid documents and successfully submitted their bids. These were the **4J Farm Ventures and Agrivet Supply, Envireau Pacific, Inc., and Unified Tillers Agriculture Cooperative**;

WHEREAS, based on the preliminary deliberation, the two bidders have been found eligible and compliant with the requirements while the other one bidder has been declared as failed;

WHEREAS, upon opening of bid documents, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on June 10, 2025 to determine the lowest calculated bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation:

- **Unified Tillers Agriculture Cooperative** is the lone bidder for Lots 1 & 4;
- **4J Farm Ventures and Agrivet Supply** is the lone bidder for Lot 5. Their request for reconsideration was granted by the BAC specifying the reflection of "comply" is true to all of the technical specifications reflected in the row;
- **Envireau Pacific, Inc.** is the lone bidder for Lot 6;
- There were no bidders for Lots 2&3;

WHEREAS, the BAC hereby resolves the following:

1. To declare **Unified Tillers Agriculture Cooperative, 4J Farm Ventures and Agrivet Supply, and Envireau Pacific, Inc.** as the lone bidders, subject to post-qualification;

WHEREAS, to conduct post-qualification process to verify the eligibility, legal, technical, and financial requirements of the lone and lowest calculated bids;

WHEREAS, after conducting the Post-Qualification Evaluation on June 16-20, 2025, the BAC determined the bidders met all legal, technical, and financial requirements and are deemed as the Lone and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, IT IS HEREBY RESOLVED, to recommend the award of the contracts to the following bidder:
