BAC RESOLUTION ON THE RECOMMENDATION FOR THE AWARD OF BIDS FOR THE PROCUREMENT OF AGRICULTURAL INPUTS (C5)

Resolution No. 114 - 2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, www.da.caraga.gov.ph and www.philgeps.net, on May 14, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Procurement Of Agricultural Inputs (C5)** under **Corn Program** with a total Approved Budget for the Contract (ABC) of **One Million Nine Hundred Ninety-Seven Thousand Five Hundred Eighty Pesos (₱1,997,580.00);**

WHEREAS, a pre-bid conference was conducted as scheduled on May 22, 2025 at the DA 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through bit.lv/Prebid-CodeC-05222025;

WHEREAS, the opening of bids was conducted as scheduled on June 3, 2025 at the DA 13 Conference Hall, Department of Agriculture-Caraga Region, Capitol Site, Butuan City which can be participated virtually through bit.ly/Opening-CodeC-06032025;

WHEREAS, there was only one bidder, namely, 4J Farm Ventures Agrivet Supply;

WHEREAS, upon opening of bid documents, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents. The bids were evaluated and rated as "Failed" due to no statement of "comply and not comply" to each and individual parameters of technical specifications, however, **4J Farm Ventures Agrivet Supply** has requested for reconsideration specifying that the "comply" is true to all specifications stated within the row wherein the BAC has granted;

WHEREAS, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on June 10, 2025 to determine the single bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **4J Farm Ventures Agrivet Supply** is the lone bidder and subject for post qualification;

WHEREAS, after conducting the Post-Qualification Evaluation on June 16-20, 2025, the BAC determined that **4J Farm Ventures Agrivet Supply** met all legal, technical, and financial requirements and is the Lone and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, RESOLVES, to recommend the award of the contract with a total amount of ₱1,993,076.80 to 4J Farm Ventures Agrivet Supply;
