

BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF ANIMAL FEEDS AND BIOLOGICS - NEGOTIATED PROCUREMENT

**Resolution No. 124-2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last May 13, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Animal Feeds and Biologics under AMIA with a total Approved Budget for the Contract (ABC) of **One Million Nine Hundred Eighty Seven Thousand Nine Hundred Pesos (P 1,987,900.00)** with procurement by lot as follows:

WHEREAS, a pre-bid conference was held at the AMAD mini Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated through face to face last May 20, 2025 as scheduled;

WHEREAS, an opening of bids was conducted on May 23, 2025 at the 3rd Floor Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, which can be participated through face to face;

WHEREAS, there were three (3) bidders who bought and submitted their bids. These were the **Pacifica Agrivet Supply, Moonstar Veterinary Clinic, and Butuan Veterinary Clinic** rated as "PASSED" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon the opening of the bids, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents. The bids were evaluated and rated as follows:

WHEREAS, upon deliberation of the detailed bid evaluation on May 27, 2025, the BAC determined that the bid submitted by **Pacifica Agrivet Supply** as the Lowest Calculated Bid and is subjected for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification on June 5, 2025 to **Pacifica Agrivet Supply** having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on June 11, 2025, it was declared that **Pacifica Agrivet Supply** has passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;




