

**BAC RESOLUTION ON THE RECOMMENDATION FOR AWARD FOR THE LABOR  
AND MATERIALS FOR THE CONSTRUCTION OF GOAT HOUSE (B16-LOT 3)**

**Resolution No. 087-2025

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites, [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net), on March 7, 2025 and posted on the Bulletin Board of this office continuously for 7 calendar days for **Labor And Materials For The Construction Of Goat House (B16-Lot 3)** under **Livestock Program** with a total Approved Budget for the Contract (ABC) of **Six Million Pesos (₱6,000,000.00)**;

WHEREAS, a pre-bid conference was conducted as scheduled on March 17, 2025 at the DA 13 Conference Hall, Butuan City which can be participated virtually through <https://bit.ly/Prebid-CodeB-03172025>;

WHEREAS, the opening of bids was conducted as scheduled on March 31, 2025 at the DA 13 Conference Hall, Butuan City;

WHEREAS, only one (1) bidder purchased bid documents and successfully submitted bid for lot 3, namely, **EYT Construction**;

WHEREAS, upon opening of bid documents, the BAC members conducted an examination of the submitted technical and financial components to verify the completeness and compliance of the required documents. The bids were evaluated and rated as "PASSED" for lot 3;

WHEREAS, based on the preliminary deliberation, **EYT Construction** has been found eligible and compliant with the requirements;

WHEREAS, the BAC, with the assistance of the Technical Working Group (TWG), conducted a detailed bid evaluation on April 11, 2025 to determine the single bid based on the completeness, accuracy, and responsiveness of the financial proposals in accordance with the criteria set forth in the bidding documents;

WHEREAS, based on the detailed evaluation, **EYT Construction** was the lone bidder and subjected for post-qualification process to verify the eligibility, legal, technical, and financial requirements;

WHEREAS, after conducting the Post-Qualification Evaluation, the BAC determined that **EYT Construction** met all legal, technical, and financial requirements and deemed as the Lone and Responsive Bidder;

WHEREAS, the BAC, after careful deliberation and verification of submitted documents, **RESOLVES AS IT IS HEREBY RESOLVED**, to recommend the award of the contract with a total amount of **₱5,984,819.40** to **EYT Construction**;

NOW, THEREFORE, the BAC recommends the award of the contract for the **Labor And Materials For The Construction Of Goat House (B16-Lot 3)** under **Livestock Program** to **EYT Construction**, subject to the approval of the Head of the Procuring Entity (HOPE) and compliance with post-award requirements as their bids were considered the Lone and Responsive Bid;
