**A RESOLUTION RECOMMENDING THE AWARD FOR THE (U15) PROCUREMENT FOR THE SUPPLY  
AND DELIVERY OF 10 units 4WD TRACTOR**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last January 30, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of 10 units WD Tractor under the Rice Program;

WHEREAS, an opening of bids was conducted last February 22, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were seven (7) bidders that responded to the invitation, namely: Fortunetract Agro Sales Inc., D' Brothers Int'l Trading, Ford Tactor Philippines, Flex O-Viva Industries, P.I. Farm Products Inc., Abomar Equipment Sales Corp. and Agrigrowth Int'l Corp.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that only Abomar Equipment Sales Corp. did not pass the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Fortunetract Agro Sales Inc.' bid offer is considered the Lowest Calculated Bid however there was a discrepancy in the AMTEC Test Result submitted thus post disqualified;

WHEREAS, the second lowest calculated bid D' Brothers Int'l Trading was disqualified after post qualification in the requirement of Service Center in which was found out non-operational;

WHEREAS, Ford Tractor Philippines' bid offer is considered the Lowest Calculated Bid and upon further evaluation and deliberation said supplier is considered the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 10 units 4WD Tractor to FORD TRACTOR PHILIPPINES INC. as the bid is considered the Lowest Calculated and Responsive Bid;
