**A RESOLUTION RECOMMENDING THE AWARD FOR (E1) THE PROCUREMENT FOR THE
SUPPLY AND DELIVERY OF 6 UNITS RICE COMBINE HARVESTER**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last August 7, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of 6 units Rice Combine Harvester under the Rice Program;

WHEREAS, an opening of bids was conducted last August 27, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: Ford Tractor Philippines, Inc., All Certified Equipment Trading Corp. and Fortunetract Agro-Sales Inc.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Ford Tractor Philippines, Inc.'s bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation post-qualification and deliberation conducted by the BAC members, it was found out that Ford Tractor Philippines, Inc.'s bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 6 units Rice Combine Harvester to Ford Tractor Philippines, Inc. as the bid is considered the Lowest Calculated and Responsive Bid;

RESOLVED, this 16th day of September 2019 at Butuan City, Philippines.


