WHEREAS, the Department of Agriculture CARAGA had published an Invitation To Bid in the websites (www.da.caraga.gov.ph and www.philgeps.net) last November 26, 2016 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of 10 units Hand Tractor with an ABC of One Million Three Hundred Thousand Pesos under the Rice Program;

WHEREAS, an opening of bids was conducted last December 20, 2016 at the DA Conference Room as scheduled.

WHEREAS, there were four bidders that responded to the invitation, the BASIC AGRI INDUSTRIAL SALES, 3R METAL CRAFT, AGRI COMPONENT CORPORATION AND FORTUNE TRACT AGRO SALES;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that said bidder passed the eligibility and technical requirements;

WHEREAS, upon further evaluation and post qualification of the submitted proposal by the BAC Members, 3R METAL CRAFT was the lowest bid however it does not comply to the minimum specification requirement thus FORTUNETRACT AGRO SALES was declared to have the lowest calculated and responsive bid.



RESOLVED, this 6th day of February, 2017 at Butuan City, Philippines.






