WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last October 5, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Various Breeder Stocks for Lots 4 and 6 under the Livestock Program;

WHEREAS, an opening of bids was conducted last October 25, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: Julimons Enterprises, Xynara Therese Nursery and Tommy's Hogs and Cattle;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;


WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Xynara Therese Nursery's and Tommy's Hogs and Cattle's bid offer are considered the Lowest Calculated Bids and thus declared the Lowest Calculated and Responsive Bids as tie;

WHEREAS, the breaking of the tie was conducted through tossing of coin on November 6, 2017 and resulted with Tommy's Hogs and Cattle as the winner for Lots 4 and 6;






