

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Xynara Therese Nursery's bid offer is considered the Lowest Calculated Bid and thus declared the Lowest Calculated and Responsive Bid;






