WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last October 27, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Catering And Billeting Services For The 13<sup>th</sup> Mindanao Wide PAFC Summit On November 20-23, 2017 under RAFC-PMED;

WHEREAS, an opening of bids was conducted last November 15, 2017 at the DA Conference Room with Supplemental Bid Bulletin (moved to 2:00 pm of the same day);

WHEREAS, there were two (2) bidders that responded to the invitation, namely: Balanghai Hotel & Convention Center Corp. and VCDU Prince Hotel Inc. ;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that VCDU Prince Hotel, Inc.'s bid offer is considered the Lowest Calculated Bid and thus declared the Lowest Calculated and Responsive Bid;


