WHEREAS, the Department of Agriculture CARAGA had published an Invitation To Bid in the websites (www.da.caraga.gov.ph and www.philgeps.net) last November 26, 2016 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of 33 units Hand Tractor with an ABC of Eight Million Two Hundred Fifty Thousand Pesos under the HVCD Program;

WHEREAS, an opening of bids was conducted last December 20, 2016 at the DA Conference Room as scheduled.

WHEREAS, there were two bidders that responded to the invitation, namely; MEGAMIGHT ENTERPRISES AND P.I FARM PRODUCTS, INC.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that said bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation and post-qualification of the submitted proposal by the BAC Members, MEGAMIGHT ENTERPRISES failed to comply with the specifications, hence, the 2nd lowest bidder P.I FARM PRODUCTS, INC. was evaluated and found to have the lowest calculated and responsive bid;


