WHEREAS, the Department of Agriculture CARAGA had published an Invitation To Bid in the websites (www.da.caraga.gov.ph and www.philgeps.net) last November 26, 2016 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Drugs and Biologics (7 Lots) with an ABC of Five Million Six Hundred Seventy Five Thousand Pesos under the Livestock Program;

WHEREAS, an opening of bids was conducted last December 19, 2016 at the DA Conference Room as scheduled.

WHEREAS, there were two bidders that responded to the invitation, namely; P & J AGRICULTURAL TRADING, INC. AND PACIFICA AGRIVET SUPPLIES, INC.;








WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that said bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation and post-qualification of the submitted proposal by the BAC Members, P & J AGRICULTURAL TRADING, INC. was declared to have the lowest calculated and responsive bid for Lot 1, 2, 4, 6 and 7 only and PACIFICA AGRIVET SUPPLIES, INC. for Lot 3 and 5;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the OIC, Regional Executive Director, Alberto D. Ocampo, Jr. to award the supply of Drugs and Biologics (Lot 1-Injectable/Soluble Supplements, Lot 2-Dewormer, Lot 4-Antibiotics, Lot 6-Anti-protozoans, and Lot 7-Anesthetics/Tranquillizers) to P & J AGRICULTURAL TRADING, INC. and Drugs and Biologics (Lot 3-Vaccines and Lot 5-Anti-inflammatory) to PACIFICA AGRIVET SUPPLIES, INC. as the bid is considered the Lowest Calculated and Responsive Bid, hence, most advantageous to the government;
