WHEREAS, the Department of Agriculture CARAGA had published an Invitation To Bid in the websites (www.da.caraga.gov.ph and www.philgeps.net) last November 26, 2016 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of 13 units Corn Mill with an ABC of Five Million Eight Hundred Fifty Thousand Pesos under the Corn Program;

WHEREAS, an opening of bids was conducted last December 20, 2016 at the DA Conference Room as scheduled.

WHEREAS, there were four bidders that responded to the invitation, namely; PI FARM PRODUCTS, INC., AGRI COMPONENT CORP., GLOBAL MARKETING & CONSTRUCTION CORP., AND MEGAMIGHT ENTERPRISES;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that said bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation and post-qualification of the submitted proposal by the BAC Members, MEGAMIGHT ENTERPRISES failed to comply with the specifications, hence, the 2<sup>nd</sup> lowest bidder, PI FARM PRODUCTS INC. was evaluated and found to have the lowest calculated and responsive bid;


