WHEREAS, the Department of Agriculture Regional-CARAGA had published an Invitation To Bid in the websites ([www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net)) last December 9, 2016 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Various Planting Materials under HVCD Program with 4 Lots;

WHEREAS, an opening of bids was conducted last December 29, 2016 at the DA Conference Room as scheduled.

WHEREAS, there were five (5) bidders that responded to the invitation, namely: DAYOT PLANT NURSERY, BINAHON AGROFORESTRY FARM, FEDUCO TREE NURSERY AND AGRO FOREST PLANTATION, ST. PADRE PIO'S GARDEN AND RENEL'S FRUIT NURSERY;


WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that the said bidders passed the eligibility and technical requirements;


WHEREAS, upon further evaluation and post qualification by the BAC, Lot 2-47,000 pcs Lansones and Lot 4-40,000 pcs Mangosteen to Binahon Agro Forestry Farm and Lot 1-108, 400 Pineapple Suckers and Lot 3-45,000 pcs Rambutan to St Padre Pio's Garden were declared as lowest calculated and responsive bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the OIC- Regional Executive Director, Alberto D. Ocampo, Jr. to award the supply of Lot 2-47,000 pcs Lansones and Lot 4-40,000 pcs Mangosteen to Binahon Agro Forestry Farm and Lot 1-108, 400 Pineapple Suckers and Lot 3-45,000 pcs Rambutan to St Padre Pio's Garden as the bid is considered the Lowest Calculated and Responsive Bid, hence, most advantageous to the government;


