A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT OF HYBRID RICE SEEDS

WHEREAS, the Department of Agriculture CARAGA had published an Invitation To Bid in the websites (www.da.caraga.gov.ph and www.philgeps.net) last November 26, 2016 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Hybrid Rice Seeds with an ABC of Five Million One Hundred Fifty Thousand Pesos under the Rice Program;

WHEREAS, an opening of bids was conducted last December 19, 2016 at the DA Conference Room as scheduled.

WHEREAS, there were two bidders that responded to the invitation, the SL AGRITECH CORPORATION AND SEEDWORKS PHILIPPINES, INC.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that said bidder passed the eligibility and technical requirements;


WHEREAS, upon further evaluation and post qualification of the submitted proposal by the BAC Members, SEEDWORKS PHILIPPINES, INC. was the lowest bid however it does not comply to the minimum specification requirement of 18 kgs per bag thus SL AGRITECH CORPORATION was declared to have the lowest calculated and responsive bid for Lot -1.


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the OIC, Regional Executive Director, Alberto D. Ocampo, Jr. to award the supply of Lot 1- to SL AGRITECH CORPORATION as the bid is considered the Single Calculated and Responsive Bid and to conduct rebidding for Lot 2- 350 bags Hybrid Rice Seeds due to no bid receive, hence, most advantageous to the government;


