A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT OF  
 3,292 BAGS HYBRID CORN SEEDS

WHEREAS, the Department of Agriculture CARAGA had published an Invitation To Bid in the websites ([www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net)) last November 26, 2016 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of 3,292 bags Hybrid Corn Seeds with an ABC of Sixteen Million Four Hundred Sixty Thousand Pesos;

WHEREAS, an opening of bids was conducted last December 19, 2016 at the DA Conference Room as scheduled.

WHEREAS, there were three bidders that responded to the invitation, namely; ASIAN HYBRID TECHNOLOGIES, SEEDWORKS PHILIPPINES, INC. AND JEDECO TRADING CORPORATION;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that said bidders passed the eligibility and technical requirements;


WHEREAS, upon further evaluation and post-qualification of the submitted proposal by the BAC Members, SEEDWORKS PHILIPPINES, INC. was declared to have the lowest calculated and responsive bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the OIC, Regional Executive Director, Alberto D. Ocampo, Jr. to award the supply of 3,292 bags Hybrid Corn Seeds to SEEDWORKS PHILIPPINES, INC. as the bid is considered the Lowest Calculated and Responsive Bid, hence, most advantageous to the government;






