A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT OF
13 UNITS MECHANICAL SHELTER

WHEREAS, the Department of Agriculture CARAGA had published an Invitation To Bid in the websites (www.da.caraga.gov.ph and www.philgeps.net) last November 26, 2016 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of 13 units Mechanical Shelter with an ABC of Three Million Two Hundred Fifty Thousand Pesos under the Corn Program;

WHEREAS, an opening of bids was conducted last December 20, 2016 at the DA Conference Room as scheduled;

WHEREAS, there were six bidders that responded to the invitation, namely; BASIC AGRI INDUSTRIAL SALES, PI FARM PRODUCTS, INC., SUKI TRADING CORP., AGRI COMPONENT CORP., FORTUNETRACT AGRO-SALES INC. AND MEGAMIGHT ENTERPRISES;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that said bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation and post-qualification of the submitted proposal by the BAC Members, BASIC AGRI INDUSTRIAL SALES, PI FARM PRODUCTS, INC., AGRI COMPONENT CORP., FORTUNETRACT AGRO-SALES INC. AND MEGAMIGHT ENTERPRISES failed to comply with the specifications, hence, the 6th lowest bidder, SUKI TRADING CORPORATION was evaluated and found to have the lowest calculated and responsive bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the OIC, Regional Executive Director, Alberto D. Ocampo, Jr. to award the supply of 13 units Mechanical Shelter to SUKI TRADING CORPORATION as the bid is considered the Lowest Calculated and Responsive Bid, hence, most advantageous to the government;




