**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT OF

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last May 30, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of 1,500 bags Urea and 1,500 bags Complete Inorganic Fertilizer under the HVCD Program;

WHEREAS, an opening of bids was conducted last June 15, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: JEELS MASAGANA FARM SUPPLY, INC., PACIFICA AGRIVET SUPLPIES, INC. AND J-777 AGRI MARKETING CORP.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that the said bidder passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that JEELS MASAGANA FARM SUPPLY, INC.'s bid offer is considered the Lowest Calculated Bid and thus declared the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the supply and delivery of 1,500 bags Urea and 1,500 bags Complete Inorganic Fertilizer to JEELS MASAGANA FARM SUPPLY, INC. as the bid is considered the Lowest Calculated and Responsive Bid;






