WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last May 30, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of 10 units Pump Irrigation System Open Source With Complete Accessories under the Rice Program;

WHEREAS, an opening of bids was conducted last June 15, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: MEGAMIGHT ENTERPRISES, SUPERTRADE ENTERPRISES AND SUKI TRADING CORPORATION;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that the said bidders passed the eligibility and technical requirements;


WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that SUPERTRADE ENTERPRISES AND SUKI TRADING CORPORATION'S offered units failed to comply the technical specifications

WHEREAS, MEGAMIGHT ENTERPRISES' bid offer is considered the Lowest Calculated Bid and thus declared the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the supply and delivery of 10 units Pump Irrigation System Open Source With Complete Accessories to MEGAMIGHT ENTERPRISES as the bid is considered the Lowest Calculated and Responsive Bid;
