A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT FOR THE CONTRACTUAL SERVICES FOR SECURITY GUARDS

WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 18, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Contractual Services for Security Guards under the Admin Division;

WHEREAS, an opening of bids was conducted last December 11, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: Commando Security Service Agency Inc. and Visa Security Services;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility and technical requirements;


WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Visa Security Services' bid offer is considered the Lowest Calculated Bid and thus declared the Lowest Calculated and Responsive Bid;


WHEREAS, based on Purchase Request the Scheduled Services to be conducted is from February 2018 to January 2019. Upon further deliberation and due to some technicalities regarding administrative and budgetary concerns, the period of Service is changed to January 2018 to December 2018;
