WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last May 26, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Labor and Materials for the Construction of Line Canal at ILD, Taguibo, Butuan City under the Corn Program;

WHEREAS, an opening of bids was conducted last June 18, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were seven (7) bidders that responded to the invitation, namely: Poliran Builders Corp., GC Construction, Tesar Builders, Mair Construction & Gen. Merchandise, Jimberns Builders & Construction Supply, AA Construction Supply and C&R Construction & Supply;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that only C&R Construction & Supply did not pass the eligibility and technical requirements;







WHEREAS, upon further evaluation of the submitted proposal conducted by the Technical Working Group, it was found out that Poliran Builders Corp.'s bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation and deliberation conducted by the BAC, it was found out that Poliran Builders Corp.'s bid offer is considered the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Labor and Materials for the Construction of Line Canal at ILD, Taguibo, Butuan City to Poliran Builders Corp.'s as the bid is considered the Lowest Calculated and Responsive Bid;
