**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT FOR THE SUPPLY AND DELIVERY OF CONVENTIONAL HYBRID CORN SEEDS (Lots 1&2)**

WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last May 26, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Supply and Delivery of Conventional Hybrid Corn Seeds (Lots 1&2) under the Corn Program;

WHEREAS, an opening of bids was conducted last June 18, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: Miracle Hybrid Corn Seed, Asian Hybrid Seed Technologies Inc. and Roy Agribest Philippines, Inc.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal by the technical working group, it was found out that Miracle Hybrid Corn Seed's bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC it was found out that Miracle Hybrid Corn Seed's bid offer is considered the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Conventional Hybrid Corn Seeds Lots 1&2 to Miracle Hybrid Corn Seed as the bid is considered the Lowest Calculated and Responsive Bid;
