WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 8, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Supply and Delivery of 10 units Farm Tractor under the Corn Program;

WHEREAS, an opening of bids was conducted last November 28, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were seven (7) bidders that responded to the invitation, namely: Ford Tractor Philippines, Fortune Tract Agro-Sales Inc., Agri-Component Corp, Super Trade Machinery Global Inc., Filholland Corp., All Certified Equipment Trading Corp. and Suki Trading Corp.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Ford Tractor Philippines' bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation during post qualification it was found out that Ford Tractor Philippines' bid offer is considered the Lowest Calculated and Responsive Bid;






