



**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT FOR THE

WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 18, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Supply and Delivery of Various Agricultural Supplies for Techno Demo Farms Lots 2-4 under the HVCD Program;

WHEREAS, an opening of bids was conducted last December 11, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: Jeels Masagana Farm Supply, Inc. and J-777 Agri Marketing Corp.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility and technical requirements;


WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that J-777 Agri Marketing Corp.'s bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation during post qualification it was found out that J-777 Agri Marketing Corp.'s bid offer is considered the Lowest Calculated and Responsive Bid;


