**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT FOR THE

WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 10, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Supply and Delivery of 3,000 bags Urea under the Rice Program;

WHEREAS, an opening of bids was conducted last November 29, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were four (4) bidders that responded to the invitation, namely: Pacifica Agrivet Supplies Inc., Jeels Masagana Farm Supply, Inc., Modern Time Ent. Inc. and J-777 Agri Marketing;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Modern Time Ent. Inc.'s bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation during post qualification it was found out that Modern Time Ent. Inc.'s bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 3,000 bags Urea to Modern Time Ent. Inc. as the bid is considered the Lowest Calculated and Responsive Bid;


