WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that Butuan Seed Producers Cooperative passed the eligibility and technical requirements;







Monteagudo to award the Procurement for the Supply and Delivery of Inbred Rice Seeds (Certified) (Wet Season) Lot 1- 4,650 bags to Butuan Seed Producers Cooperative as the bid is considered the Single Calculated and Responsive Bid;
