WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Bayugan Seeds Center's bid offer is considered the Single Calculated Bid;


WHEREAS, upon further evaluation during post qualification it was found out that Bayugan Seeds Center's bid offer is considered the Single Calculated and Responsive Bid;

RESOLVED, this 23rd day of January at Butuan City, Philippines.




