WHEREAS, an opening of bids was conducted last November 29, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: Gilmed Enterprises and Services, Harnwell Chemicals Corp. and Krypton Industrial Resources;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;


WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Krypton Industrial Resources' bid offer is considered the Lowest Calculated Bid;



Monteagudo to award the Procurement for the Supply and Delivery of Various Laboratory Equipment Lots 2, 3 and 5 to Krypton Industrial Resources as the bid is considered the Lowest Calculated and Responsive Bid;




