WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 18, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Supply and Delivery of 3,150 bags OPV White Corn Seeds under the Corn Program;

WHEREAS, an opening of bids was conducted last December 11, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: Northland Agri-Products and Services, Miracle Hybrid Corn Seeds and RJR Agro Industrial Enterprises;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Northland Agri-Products and Services' bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation during post qualification it was found out that Northland Agri-Products and Services' bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 3,150 bags OPV White Corn Seeds to Northland Agri-Products and Services as the bid is considered the Lowest Calculated and Responsive Bid;


