WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Jeels Masagana Farm Supply, Inc.'s bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation during post qualification it was found out that Jeels Masagana Farm Supply, Inc.'s bid offer is considered the Lowest Calculated and Responsive Bid;




