WHEREAS, an opening of bids was conducted last November 28, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were five (5) bidders that responded to the invitation, namely: Suki Trading Corp., Fortune Tract Agro-Sales Inc., Kuliglig Farm Machineries, Sanico Welding Shop and Basic Agri Industrial Sales;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Fortune Tract Agro-Sales Inc.'s bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation during post qualification it was found out that Fortune Tract Agro-Sales Inc.'s bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 10 units Hand Tractor to Fortune Tract Agro-Sales Inc. as the bid is considered the Lowest Calculated and Responsive Bid;






