WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last January 12, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Supply and Delivery of Various Processing Equipment for Cacao/Coffee Lots 1-2 under the HVCD Program;

WHEREAS, an opening of bids was conducted last February 1, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: Visayan Northstar Enterprises and Tropics Agro-Industries Corp.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Visayan Northstar Enterprises' bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation during post qualification it was found out that Visayan Northstar Enterprises' bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Various Processing Equipment for Cacao/Coffee Lots 1-2 to Visayan Northstar Enterprises as the bid is considered the Lowest Calculated and Responsive Bid;


