



A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE ESTABLISHMENT OF SOLAR POWERED IRRIGATION SYSTEM (SPIS) AT ORO, ESPERANZA, AGUSAN DEL SUR

WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last January 12, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement of Labor and Materials for the Establishment of Solar Powered Irrigation System (SPIS) at Oro, Esperanza, Agusan del Sur under the Rice Program;

WHEREAS, an opening of bids was conducted last February 1, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were four (4) bidders that responded to the invitation, namely: Victa Construction Marketing and General Services, C&R Construction and Supply, GC Construction and FFJJ Construction;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that only GC Construction and FFJJ Construction passed the eligibility and technical requirements;


WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that GC Construction's bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation and post qualification it was found out that GC Construction's bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Labor and Materials for the Establishment of Solar Powered Irrigation System (SPIS) at Oro, Esperanza, Agusan del Sur to GC Construction as the bid is considered the Lowest Calculated and Responsive Bid;


