WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 8, 2017 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Supply and Delivery of 3 units 4WD Tractor under the Rice Program;

WHEREAS, an opening of bids was conducted last November 28, 2017 at the DA Conference Room as scheduled;

WHEREAS, there were six (6) bidders that responded to the invitation, namely: Ford Tractor Philippines, Filholland Corp., Kuliglig Farm Machineries, Suki Trading Corp., Fortune Tract Agro-Sales Inc., Super Trade Machinery Global Inc.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Ford Tractor Philippines' bid offer is considered the Lowest Calculated Bid;


