**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT FOR THE  
SUPPLY AND DELIVERY OF 3,000L FUNGICIDE/BACTERICIDE**

WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 24, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Supply and Delivery of 3,000L Fungicide/Bactericide under the Rice Program;

WHEREAS, an opening of bids was conducted last April 16, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: J-777 Agri Marketing Corporation and AHCIL Laboratory Inc.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that J-777 Agri Marketing Corporation passed the eligibility and technical requirements;

WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that J-777 Agri Marketing Corporation was not responsive to submit post qualification requirements within the given time thus making AHCIL Laboratory Inc. the Lowest Calculated Bid;

WHEREAS, upon further evaluation and deliberation, it was found out that AHCIL Laboratory Inc.'s bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 3,000L Fungicide/Bactericide to AHCIL Laboratory Inc. as the bid is considered the Lowest Calculated and Responsive Bid;
