WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Nissan CDO Distributor Inc.'s bid offer is considered the Single Calculated Bid;

WHEREAS, upon further evaluation and post qualification it was found out that Nissan CDO Distributor Inc.'s bid offer is considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 7 units Motor Vehicle (Pick-up Truck) to Nissan CDO Distributor Inc. as the bid is considered the Single Calculated and Responsive Bid;


