



**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT FOR THE  
LABOR AND MATERIALS FOR THE CONSTRUCTION OF CABANGHAN DAM AT BUENAVISTA,

WHEREAS, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 24, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the procurement for the Labor and Materials for the Construction of Cabanghan Dam at Buenavista, Agusan del Norte under the Rice Program;

WHEREAS, an opening of bids was conducted last April 16, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were three (3) bidders that responded to the invitation, namely: RMF Construction and Supply, BN Builders & Construction Supplies and Poliran Builders Corp.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;


WHEREAS, upon further evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that RMF Construction and Supply's bid offer is considered the Lowest Calculated Bid;


WHEREAS, upon further evaluation, post qualification and deliberation, it was found out that BN Builders & Construction Supplies' bid offer is considered the Lowest Calculated and Responsive Bid since RMF Construction and Supply's bid offer was post disqualified;


