



**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE PROCUREMENT FOR THE
SUPPLY AND DELIVERY OF VARIOUS FERTILIZERS LOTS 1-3**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last October 30, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Various Fertilizers under the Corn Program;

WHEREAS, an opening of bids was conducted last November 20, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were two (2) bidders that responded to the invitation, namely: PACIFICA AGRIVET SUPPLIES, INC. AND JEELS MASAGANA FARM SUPPLIES, INC.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that the both bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that JEELS MASAGANA FARM SUPPLIES, INC.'S bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that JEELS MASAGANA FARM SUPPLIES, INC.'S bid offer is considered the Lowest Calculated and Responsive Bid;

WHEREAS, as per Circular No. 2019-1 dated January 3, 2019 guidelines for the release of funds for the first quarter of FY 2019 was circulated in lieu for the pending approval of GAA 2019;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the procurement for the Supply and Delivery of Various Fertilizers Lots 1-3 to JEELS MASAGANA FARM SUPPLIES, INC. as the bid is considered the Lowest Calculated and Responsive Bid;
