WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last October 31, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of Inbred Rice Seeds (Certified) Lot 2- 7,366 bags under the Rice Program;

WHEREAS, an opening of bids was conducted last November 21, 2018 at the DA Conference Room as scheduled;

WHEREAS, there was one (1) bidder that responded to the invitation, namely: OJM Seed Producer and Agricultural Services;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that OJM Seed Producer and Agricultural Services passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that OJM Seed Producer and Agricultural Services' bid offer is considered the Single Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that OJM Seed Producer and Agricultural Services' bid offer is considered the Single Calculated and Responsive Bid;




