**A RESOLUTION DECLARING THE WINNING BIDDER FOR (B1) THE PROCUREMENT FOR
THE SUPPLY AND DELIVERY OF 315,000 PCS ABACA PLANTING MATERIALS (SUCKERS)**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 29, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of 315,000 pcs Abaca Planting Materials (Suckers) under the SAAD Program;

WHEREAS, an opening of bids was conducted last December 20, 2018 at the DA Conference Room as scheduled;

WHEREAS, there was one (1) bidder that responded to the invitation, namely: ST. PADRE PIOS GARDEN;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that ST. PADRE PIOS GARDEN passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that ST. PADRE PIOS GARDEN'S bid offer is considered the Single Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that ST. PADRE PIOS GARDEN'S bid offer is considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 315,000 pcs. Abaca Planting Materials (Suckers) to ST. PADRE PIOS GARDEN as the bid is considered the Single Calculated and Responsive Bid;
