WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that VANN HAWK AGRO CHEMICALS INC.'S bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation, post qualification and deliberation conducted by the BAC members, it was found out that VANN HAWK AGRO CHEMICALS INC.'S bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of Pesticides Lot 3- 336L Insecticide to VANN HAWK AGRO CHEMICALS INC. as the bid is considered the Lowest Calculated and Responsive Bid;

RESOLVED, this 2nd day of May at Butuan City, Philippines.






