



**A RESOLUTION DECLARING THE WINNING BIDDER FOR THE (U18) PROCUREMENT FOR  
THE SUPPLY AND DELIVERY OF 40 UNITS THRESHER**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last January 30, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of 40 units Thresher under the Rice Program;

WHEREAS, an opening of bids was conducted last February 22, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were nine (9) bidders that responded to the invitation, namely: AGRIMACH CG CORP., SANICO FABRICATION & MACHINERIES, MEGAMIGHT ENTERPRISES, SUPERTRADE MACHINERY GLOBAL INC., FLEX O-VIVA INDUSTRIES, ACT MACHINERIES AND METALCRAFT CORP., AGRIGROWTH INT'L CORP., EUNICS MARKETING AND SUKI TRADING;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that only EUNICS MARKETING did not pass the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that AGRIMACH CG CORP.'S bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon post-qualification and deliberation conducted by the BAC members, it was found out that AGRIMACH CG CORP.'S bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 40 units Thresher to AGRIMACH CG CORP. as the bid is considered the Lowest Calculated and Responsive Bid;




