



A RESOLUTION DECLARING THE WINNING BIDDER FOR (A38) THE PROCUREMENT FOR THE SUPPLY AND DELIVERY OF 2 UNITS 4WD TRACTOR (35HP)

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last October 31, 2018 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of 2 units 4WD Tractor (35hp) under the Rice Program;

WHEREAS, an opening of bids was conducted last November 21, 2018 at the DA Conference Room as scheduled;

WHEREAS, there were six (6) bidders that responded to the invitation, namely: FORTUNETRACT AGRO SALES, D' BROTHERS INT'L TRADING CORP., FORD TRACTOR PHILIPPINES, INC., P.I FARM PRODUCTS INC., SUPER TRADE MACHINERY GLOBAL INC. AND HEXAGON DISTRIBUTING CORP.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility and technical requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that FORD TRACTOR PHILIPPINES, INC.'S bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation and deliberation conducted by the BAC members, it was found out that FORD TRACTOR PHILIPPINES, INC.'S bid offer is considered the Lowest Calculated and Responsive Bid;

WHEREAS, Authority to Purchase from Department of Budget and Management was released last July 3, 2019;



RESOLVED, this 10th day of July at Butuan City, Philippines.


