**A RESOLUTION RECOMMENDING THE AWARD FOR (E4) PROCUREMENT FOR THE SUPPLY AND DELIVERY OF 70 UNITS PUMP AND ENGINE SET**

WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last August 7, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement for the Supply and Delivery of 70 units Pump and Engine Set under the Rice Program;

WHEREAS, an opening of bids was conducted last August 27, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were seven (7) bidders that responded to the invitation, namely: Flex-O Viva Industries Inc., P.I. Farm Products Inc., Super Trade Machinery Global Inc., Suki Trading Corp. Megamight Enterprises, Basic Agri Industrial Sales and Agri component Corp.;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that only Agri component Corp. failed to pass the eligibility requirements;

WHEREAS, a motion for reconsideration was submitted by Agri component Corp. and upon deliberation it was found out that it passed the eligibility requirements;

WHEREAS, upon evaluation of the submitted proposals of the eligible bidders and based on the deliberation conducted by the BAC members, it was found out that Super Trade Machinery Global Inc.'s bid offer is considered the Lowest Calculated Bid;

WHEREAS, upon further evaluation and deliberation conducted by the BAC members, it was found out that Super Trade Machinery Global Inc.'s bid offer is considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement for the Supply and Delivery of 70 units Pump and Engine Set to Super Trade Machinery Global Inc. as the bid is considered the Lowest Calculated and Responsive Bid;


