**A RESOLUTION RECOMMENDING THE WINNING BIDDER FOR THE LABOR AND MATERIALS  
FOR THE REHABILITATION OF GUITAS SWIP (2-FAILED BIDDINGS NEGOTIATED  
PROCUREMENT)**

**WHEREAS**, the Department of Agriculture- Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last September 12, 2019 and posted in the Bulletin Board of this office continuously for 12 calendar days for the procurement for the Labor and Materials for the Rehabilitation of Guitas SWIP (Negotiated Procurement-Two Failed Biddings) under the Rice Program;

**WHEREAS**, an opening of bids was conducted last September 24, 2019 at the DA Conference Hall as scheduled;

**WHEREAS**, there were two (2) bidders that responded to the invitation, namely: GC Construction and Aguero Construction;

**WHEREAS**, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that both bidders passed the eligibility and technical requirements;

**WHEREAS**, upon further evaluation of the submitted proposal by the technical working group, it was found out that only GC Construction's bid offer passed the eligibility and technical requirements and is considered the Single Calculated Bid;

**WHEREAS**, upon further evaluation and deliberation conducted by the BAC it was found out that GC Construction's bid offer is considered the Single Calculated and Responsive Bid;

**NOW THEREFORE**, in order to promote economy and efficiency, the BAC recommends to the Regional Executive Director, Abel James I. Monteagudo to award the Procurement of Labor and Materials for the Rehabilitation of Guitas SWIP to GC Construction as the bid is considered the Single Calculated and Responsive Bid;
