WHEREAS, the Department of Agriculture Regional- Caraga had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last September 17, 2019 and posted in the Bulletin Board of this office continuously for 7 calendar days for the Procurement Of Labor And Materials For The Establishment Of Small Ruminant Training Center (Phase II) under the Livestock Program;

WHEREAS, an opening of bids was conducted last October 8, 2019 at the DA Conference Room as scheduled;

WHEREAS, there were five (5) bidders that responded to the invitation, namely: LGTD Construction & Development, Jodel Construction, GC Construction, Poliran Builders Corp and OLIN;

WHEREAS, upon opening of the bids on the scheduled place, date and time and upon evaluation by the BAC, it was found out that all bidders passed the eligibility requirements;

WHEREAS, upon evaluation of the submitted proposal and based on the deliberation conducted by the BAC members, it was found out that Jodel Construction was considered the Lowest Calculated Bid and was subjected for post qualification;


